With reference to the Corporate Announcement submitted by the Company dated January 10, 2024 under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we would like to inform you that Government Of West Bengal, Directorate of Commercial Taxes has issued the final order in which they have reduced the amount of demand that has been raised by them in previous Show cause notice. This reduction is a result of our continuous engagement and our representations made to the department. The department, on the basis of documents presented before them, reduced the demand from Rs. 83,661,572.36 to Rs. 3,763,362.

As as per the requirement of Regulation 30 of the Listing Regulations, read with SEBI Circular SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023, we wish to inform you about the details of final order received by the Company as per **Annexure-A**.
